- Defended Arthur and Kathleen Breitman, as well as their company, in connection with securities class action lawsuits in San Francisco involving the Tezos crowdfunding, which raised over \$230 million.
- Successfully handled the defense of Cesar Millan (the "Dog Whisperer") when the Los Angeles County Department of Animal Control and District Attorney's Office investigated allegations of animal abuse tied to one of Mr. Millan's television shows. The authorities ultimately concluded Mr. Millan did nothing wrong and did not bring any charges.

- Obtained a declination to bring charges for a client from federal prosecutors in San Diego in a money laundering-related case.
- Represented Erik Voorhees, a prominent early Bitcoin adopter, in his settlement with the SEC in an investigation.
- Secured from the Los Angeles County District Attorney's Office a declination to charge a high-profile client accused of sexual assault by someone the client met on a dating app.
